Set up begins on Tuesday prior to the event. Early arrival setup is free unless open for business, charge **\$10.00** per day. No electricity is available. **Inverter** style generators with noise levels of **70 dp** or lower and RV built in generators are allowed. City water for food vendors is available. Copy of event insurance and Health permit from Lewis County for food vendors is required with application. All equipment & vehicles are required to fit within the space rented. Parking passes for one vehicle only are available. Extra vehicles are charged **\$3.00** per day parking. Camping for vendors, employees, family members & guests off the vending field is available for **\$10.00** per night. **New vendors**, to reserve a vendor spot, this form must be signed and returned with payment in full. You can indicate your vendor row of choice and will be placed in that row if available by marking on this form. Check rows at www.packwoodonline.com. Vendors unreserved will be placed on the field, first come first served. **Current vendors**, payment in full by February 1 will hold your size spot in that row for Memorial Day and payment by July 1 for Labor Day. Vendor sites must be left clean, garbage in dumpster, boxes folded flat prior to dumping. **\$100.00** charge for garbage left on site. Garbage cans will be available on the field for small items. Please check the website for any new items or manager statements that are a part of this contract. These are four day events, to help each other all vendors are required to stay until **NOON on Monday**. Make checks payable to **Jim Flint, mail to Jim Flint, P.O.
