

1896 HOMESTEAD
PACKWOOD FLEA MARKET/EVENT CAMPING APPLICATION
Huntington Road Property

This application is for campers wanting to rent camping space at the Homestead during the **Memorial Day weekend** or **Labor Day weekend** flea markets. This application is for the renting of both RV and tent spaces. All of the camping spaces are dry camping and do not have hookups of any kind. Portable toilets are available for those who need them. It is suggested that units be self-contained. Pumping of RV units is available by contacting Goebel Septic Tank Service in Chehalis in advance. There are no tables or chairs available for camp spots.

No open fires are allowed during the Labor Day weekend event. Fires are allowed during Memorial Day events, weather permitting, but must be contained in an approved outdoor above ground fire containment system. There is a public camp fire at the Homestead.

No dogs are allowed off leash and all dog poop is to be picked up and removed to an approved disposal location. Any violation of the above rule and you will be asked to leave and no refund of camping fees will be given.

This application must be signed prior to camping at the homestead either by printing online and mailing or by signing at the time of arrival at the Homestead. **Make checks payable to Jim Flint and mail with this application with payment to Jim Flint, P.O. Box 291, Packwood, WA 98361.**

ANY SIZE RV CAN BE ACCOMMODATED AT THE HOMESTEAD.

The Homestead camping area is located to the rear of the vending field in downtown Packwood. The entrance is at Huntington Road and State Route 12 just West of the Packwood Senior Center. The camping is in open fields next to the Packwood Airport and close to State Route 12. If not reserved, all camping spaces are on a first come, first served basis. Applications are required for each camping RV or tent. **WE RECOMMEND EARLY RESERVATIONS FOR GROUPS.**
